

**COMMISSION ON AGING MINUTES**

**MEMBERS PRESENT:** Nicolaus, Hanchey, Klooster, Roberts

**ORAL COMMUNICATIONS:** Under Government Code Section 54954.3, members of the audience may address the Commission on any item of interest to the public or any agenda item before or during the Commission's consideration of the item.

**ORDER OF BUSINESS:** The meeting was called to order at 5:15 P.M. A motion was made by Comm. Hanchey and seconded by Comm. Nicolaus to approve the meeting minutes of February 28, 2013.

**OLD BUSINESS:**

The resource guide was up for discussion once again. Comm. Klooster said we have \$500 available from Council Member Payne and if not used by June we lose it. It has been discussed that we could use that money for printing. Some minor changes still need to be made. All members present agreed that the front cover of the guide needs to be printed on colored paper. Comm. Klooster suggested that we go to print. Comm. Hanchey made a motion to have the guide finalized and printed. Comm. Nicolaus seconded the motion. Comm. Nicolaus suggested that we scale down the distribution of the guide to those seniors in assisted living situations as they have caregivers and resources available.

Discussion has continued regarding the Commission attending an upcoming City Council meeting. The purpose would be to present a projection of our 2013 goals and to give them copies of the updated resource guide. We would also like their input and suggestions as to how we as a commission can be more effective in the community. Comm. Roberts said he would put together an outline of what we might want to present and have it available at the next meeting. May 21, 2013 was the date tentatively set to attend the City Council meeting.

The Character Coalition was tabled until the next meeting when all members will be present.

Funds are available to pay for the yearly Galt Senior Club membership dues for 2013. Comm. Hanchey will bill the City for all commission members.

The Galt Senior Games sponsored by the Galt Rotary Club is scheduled for June 6, 2013 at the Chabolla Center. The Commission on Aging is responsible for contacting people for the resource and vendor tables. Comm. Hanchey had the list of contacts from the past years. The list was divided among the members to contact the past participants. In lieu of charging a table fee, we will ask that a donation be made to Meals on Wheels.

**NEW BUSINESS:**

Comm. Hanchey informed all members present of the upcoming AARP Driver Safety course being held at the Chabolla Center May 6<sup>th</sup> and May 13<sup>th</sup>. Each session is four hours and begins at 8:30 a.m. The cost is \$12 for AARP members and \$14 for non-members.
